1. Tournament is a Ladies trio scratch event. All entering teams must come from an OSBPA member center as of the time of competition. All entrants must hold a current season USBC adult membership card and be in good standing in their center. If the tournament does not fill completely with A teams the tournament committee has the option to add a 2nd team or add from other states if space allows.

2. Method of selecting Center Challenge Participants: USBC sanctioned averages in center with a minimum of 50 games as a regular paying member in one league. Average Deadline : **April 5th, 2019. Sport Average Conversion will be considered if the bowler is in a sport league to establish in the high 3.** Centers reserve the right to select their choice of the 3 bowlers submitted. The Proprietor has the opportunity to participate regardless of the 50 game rule.

3. Tournament will consist of 4 games of qualifying, followed by a one game total pins match double elimination bracket format. Total pins during qualifying will seed each team for bracket play. The bracket is total pins no points, or matches. Each team is guaranteed to bowl at least 6 games. Your lineup may not change once set to start the day. In case of a tie during qualifying, the highest team game will break the tie. If still tied then the highest team member game will break the tie. In case of a tie during bracket play, then a 9th & 10th frame roll off with all 3 members will take place.
